

Public Hearing Notice

Town of Stockbridge

The Planning Commission of the Town of Stockbridge will hold a hearing on the proposed revision of the Stockbridge Town Zoning Bylaws on **Tuesday, September 18, 2018 at 7:00 pm** at the **Stockbridge Meeting House (on Stockbridge Common)**. The revisions are to make the Zoning Bylaws in conformance with the Town Plan adopted by the Board of Selectmen in 2015. The Planning Commission will accept comments at this Public Hearing. The proposed Zoning Bylaws cover all lands within the Town of Stockbridge.
