Notice: This permit is issued in accordance with Title 19, Section 43 V.S.A. relative to highways within the control and jurisdiction of the Town of Stockbridge, Vermont. The issuance of this permit does not release the applicant from any requirements of statute ordinances, rules and regulations administered by other governmental agencies. The permit will be effective upon compliance with such of the requirements are applicable and continue in effect for as long as the present land use continues. Section 4416(b), as amended by Section 29 of Act No. 167 of 2014, provides that "(b) Whenever a proposed site plan involves access to a State highway, the application for site plan approval shall include a letter of intent from the Agency of Transportation confirming that the Agency has reviewed the proposed site plan and is prepared to issue an access permit under 19 V.S.A Section 1111, and setting out any conditions that the Agency proposes to attach to the Section 1111 permit." <https://vtrans.vermont.gov/planning/permitting>

Any change from the present land use will require a new permit. This permit is issued subject to the directions, restrictions and conditions contained herein, and on any attachments hereto, and covers only the work described in this application, and then only when the work is performed as directed. Violations are subject the penalties set forth in Title 19, Section 43 V.S.A. of fines of not less than \$100 nor more than \$10,000 for each violation.
